Discovery Ranch-Mapleton (F22-93408)

Dear Licensee,

This letter serves as notice that the Utah Department of Health and Human Services Office of Licensing ("Department") is removing the ban on admissions at Discovery Ranch-Mapleton ("Licensee") Residential Treatment, license number F22-93408. Admissions may resume effective January 13, 2025 based on two consecutive conditional monitoring visits dated December 19, 2024 and December 26, 2024, with no rule noncompliance cited.

The Department issued a conditional license to Licensee license number F22-93408 on November 26, 2024 in accordance with Utah Code § 26B-2-703 and Utah Admin. Code R380-600-8, because of the Licensee's failure to comply with state administrative rules and state statutes for non-compliance during the licensing period, conduct adverse to standards required to provide services and promote public trust which includes permitting the commission of neglect, harm or mistreatment, and for failing to provide applicable health and safety services for clients. All remaining conditions in the conditional license remain in effect until February 26, 2025.

Pursuant to DHHS Administrative Hearing Procedures set out in Administrative Rule R497, you may request an administrative hearing if there is a disputed issue or fact. If there is no disputed issue of fact the Department's administrative law judge may deny a request for a hearing and issue a decision based on the record. There is no issue of fact if you present facts that on their face establish the right of the Department to take the action or if the

facts do not conflict with the facts relied upon by the Department in taking its action.

If you choose to request an administrative hearing, you must submit your request to the Department in writing, within 15 calendar days of receipt of this letter. You can complete a form found on our website at [Request for Agency Action, Administrative Review](#) and include any additional documentation. The administrative proceeding shall be conducted as an informal adjudicative proceeding in accordance with Utah Code § 63G-4-203 and Utah Administrative Code Rule R497.
