NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. HOW TO ENTER

- a. These rules govern the TITANIC VOW RENEWAL CONTEST ("Contest"), which is being conducted by KSFI-FM and KSL TV ("Stations"). The Contest begins on January 26, 2026 and ends on February 8, 2026 ("Contest Dates"). Submissions may be entered online only.
- b. To enter the Contest, Nominator may submit nomination online beginning on January 26, 2026 at 12:01am and ending on February 8, 2026 at 11:59pm (MT) ("Entry Period") as follows:
 - i. To enter online, Nominator must visit www.fm100.com/contests/ or www.ksltv.com/contests/ and follow the links and instructions to submit a brief essay nominating a special couple that deserves a beautiful vow renewal ceremony on Saturday, February 14, 2026 at the Titanic Exhibition in Sandy, Utah. Online Nominators are subject to all notices posted online including the Station's Terms of Use and Privacy Policy. Each Nominator may enter only one Submission per eligible Nominee. Multiple Nominators are not permitted to share the same email address. Submissions may not be acknowledged or returned. Proof of entry of a Submission shall not be deemed proof of receipt by the Contest Administrator.
 - c. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.
 - d. Only one (1) entry/nomination per person is permitted. There will be up to a total of one (1) winner selected in the Contest.
 - e. All online entries must be received by the end of the Entry Period. Submissions will not be made available for the public to view. Submissions must be truthful.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, twenty-one (21) years of age or older, and who reside in one of the jurisdictions that make up the KSFI listening/DMA area and the KSL TV Viewing DMA. Couple being nominated must live in Utah. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of a KSL Station, Bonneville International Station, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current spouses, parents, grandparents, children, grandchildren and siblings.
- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the KSL or Bonneville International Stations are subject to the following restrictions: Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to entering the contest are not eligible to participate. Persons who have won a prize valued between \$500 and \$999 in the six (6) months prior to entering the contest are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to entering the contest are not eligible to participate.
- d. To claim a prize, the winner(s) must sign all release forms, provide valid government-issued photo identification, their complete mailing address, email address, date of birth, phone number and Social Security Number.
- e. Nominator and Nominee are required to provide truthful information. Stations will reject and delete any submission that it discovers to be false or fraudulent. The Stations will disqualify any nomination that does not meet the eligibility requirements and will also delete any entry as required by law.
- f. This Contest is subject to all applicable federal, state and local laws and regulations. By participating, both the Nominator and Nominee agree to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

3. JUDGING CRITERIA/REVIEW PERIOD

- a. A judging panel consisting of five employees of the Station ("Judges") will judge each eligible Nomination and will select a winning submission based on the following weighted criteria ("Judging Criteria"):
 - i. the unique love story of the Nominee and the impact the prize will have on the Nominee as outlined in essay (75%), and
 - ii. the content and persuasiveness of the essay (25%).

4. PRIZES

- a. One (1) prize will be awarded. Prize consists of:

- i. Entry PASSES to Titanic Exhibition for 30 adults. Passes are electronic and good for event day only unless otherwise specified. (Value \$1500)
- ii. CERTIFICATE for his/hers wedding bands from Diamonds Direct at the Shops at South Town (Value \$2500)
- iii. Flower Bouquet for Bride and Boutonniere for Groom (\$100 Value)
- iv. Wedding Lunch for 30 people catered by Olive Garden Restaurant on day of event (\$600 value)
- v. Wedding Cake and dessert for wedding party (Value \$50)

b. **The Approximate Retail Value (“ARV”) of the prize is \$4,750.**

- c. All sales, prize taxes, gratuities and any other incidentals associated with the prize are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.
- d. In no event will more than the stated number of prizes be awarded.

5. WINNER SELECTION AND NOTIFICATION

- a. One (1) prize winner will be selected in the Contest. Winner will be chosen by a panel of judges that are employees of the Stations.
- b. Odds of winning depend upon the number of eligible online nomination entries received during the applicable Entry Period.
- c. Potential winner will be notified by telephone or email at close of contest. Prize will be awarded only upon confirmation of eligibility. Upon notification or notification attempt, the potential winner will be required to respond to an IRS Form W-9 adding a social security number, affidavit of acceptance, eligibility, liability, publicity release, provide a valid government ID, and if applicable, Contest Sponsor liability release forms **within 72 hours of such notification or notification attempt or prize will be forfeited.** If a potential winner is deemed ineligible for any reason, cannot be contacted, fails to sign and return the fully executed affidavit of eligibility and/or liability/publicity release within the required time-period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize. The Station, Contest Administrator or Sponsor is not responsible for any changes in an entrant or winner's email address, phone number, mailing address or other contact information.

6. CONDITIONS

- a. Entrants must be legally married and residing in Utah at the time of nomination and at the time of the prize fulfillment. The winning couple may be required to provide a copy of their marriage certificate or other satisfactory proof of marriage. The Vow Renewal Ceremony is subject to the availability of prize Sponsors and Vendors and must take place on February 14, 2026. No alternative dates are available and the Station is not responsible for Sponsor or Vendor cancellations.
- b. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins or any other methods may void that entrant's entries and that entrant may be disqualified. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest.
- c. The Station reserves the right to modify these rules for clarification or without materially affecting the terms and conditions of the Contest, which will become effective upon announcement. To the extent the Station makes material changes to the terms and conditions of the Contest, any such material changes will be broadcast on the Station and/or posted on its websites: www.fm100.com and www.ksltv.com within twenty-four (24) hours of the change and periodically thereafter. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be required to award substitute prizes.
- d. By accepting the prize, the winning Nominee ("Winner") consent and grant irrevocable and perpetual license to Released Parties to the use of their name, photograph, likeness, voice, video, nomination, prize information (if any), or any statements made for trade, publicity, advertising, or promotional purposes, in any and all media, now known or hereafter devised, including online announcements, without limitation and without compensation, except where prohibited by law.
- e. Winner will be required to produce identification satisfactory to the Station. For example, winner(s) will be required to sign an IRS Form W-9, affidavit of eligibility and release, including a publicity release, as prepared by the Station prior to receiving their prize. Each winner will be responsible for any (federal, state, or local) taxes or fees that result from the receipt and/or use of their prize and may receive an IRS Form 1099-Misc for all prizes won from the Station in any calendar year where the aggregate value of all such prizes is \$2,000 or more. The Contest is void where prohibited by law. Any individual(s) that is found to be, or suspected of, tampering with a Contest in any way, including without limitation by making a fraudulent entry, by engaging in any "deal-making" with or between other Contest entrants or third parties, by creating a public hazard, by cheating, by engaging in improper or illegal activity, by causing interference with or the destruction of property and/or utilized public safety resources will be disqualified from participating and/or winning any prize(s), as applicable, and may be banned from any future participation in any Contest as determined by Station at its sole discretion and on a case-by-case basis.
- f. Participation in a Contest and/or acceptance of prize(s) constitutes agreement by entrant and/or nominee they release, forever discharge, indemnify, and hold harmless Station, its affiliates, parents, assigns, successors, employees, participating Contest Sponsors, agents and all others connected with them and the Contest (the "Released Parties") from

any and all liability, claims, actions, and damages sustained or incurred by participation in the said Contest, and the receipt and use of any prize(s) awarded (if any) through such Contest arising in any manner whatsoever, including but not limited to an act or omission, whether negligent, intentional or otherwise caused by Station, its affiliates, parents, assigns, successors, employees, sponsors, agents and all others connected with them and the Contest.

- g. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering, or the administration of the Contest or in the announcement of a prize; (ii) incorrect or inaccurate information, human error, failure, or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, illegible, incomplete, or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone service outages, delays, busy signals, poor signals or signal interference, accidental disconnection, equipment malfunctions, and any other technological failures; or (vi) any cancellations, delays, diversions, or substitutions or omissions by any transportation providers or any other persons or entities providing any services to Entrant(s) and/or nominee.
- h. Except where prohibited, by entering the Contest, each Nominator and Nominee agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Contest or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in Salt Lake City, Utah 84180; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied or increased. Utah law governs the interpretation and construction of these Official Rules and all aspects related thereto.

7. PRIVACY

- a.
